#### **34 WEEKS OF HARD OR CLAY COURT PLAY BEGINNING SEPTEMBER 14, 2021**

1. Acceptance of application and deposit reserves your court at the fees listed below. An acknowledgement will be sent to the group captain, who is responsible for the remittance of all monies due on court time.
2. It is understood that all players will abide by the terms and rules of Bethpage Park Tennis Center, which are announced from time to time. Management reserves the right to cancel any contract if the terms and rules are violated and retain all payments as liquidated damages.
3. **MANAGEMENT RESERVES THE RIGHT TO MAKE ALL COURT PLACEMENTS AND/OR CHANGES WHEN NECESSARY.**
4. Tennis is an active sport with open participation. Therefore, Bethpage Park Tennis Center is not responsible for those who play. All customers play tennis at their own risk. Furthermore, the group captain and all player agree to hold the club and its agents and employees harmless from all suits, claims or demands of every kind and character arising out of, by reason of, or in connection with the use by the player of the club's facilities (including, with limitation, injuries he/she may receive from other persons on the club's premises and loss, destruction or damages to the personal property of the player on the club's property) and the player further releases from all suits, claims or demands of every kind and character, which the player or his/her heirs, executors, administrators or assignees hereafter can, shall or may have or in accordance with the use of the club's facilities.
5. When the club is at fault for lost time for any reason, make-up time will be scheduled with the group captain based on court availability. Seasonal time unused by the playing group shall be deemed waived.
6. The club reserves the right to terminate this contract at any time for unsportsmanlike, ungentlemanly or unladylike conduct on the part of the player or any other reason deemed to be good and sufficient by the club's management, in which the unexpired pro-rata portion, the rental payment shall be returned to the Captain and neither the club nor the player shall be under any further liability on account of this contract. **NO REFUNDS SHALL BE MADE TO ANY PLAYER EXCEPT AS PROVIDED IN THIS PARAGRAPH.**
